### **COURT CUSTOMER COUNTER WILL BE OPEN AN ADDITIONAL DAY IN BRIDGEPORT**

Starting Thursday, July 19, the Mono County Superior Court (court) will open its court customer counter to the public at the Bridgeport Courthouse on Thursdays in addition to already being open on Tuesdays. The Bridgeport Courthouse customer counter will be open Tuesdays and Thursdays (excluding holidays and court closures) from 8:30 AM to 12:00 PM and reopen from 1:15 PM to 4:00 PM. During the open customer counter hours, the public can now come in person to pay for tickets, request traffic school, request a Court Trial or Trial by Written Declaration, make a records request, file any legal matter, schedule a wedding, and much more. Phone calls will be accepted at the Bridgeport Courthouse on Tuesdays and Thursdays from 9:00 AM to 12:00 PM. Since 2015, due to severe budget reductions the court was forced to reduce the hours the court customer counter was open at both the Bridgeport and Mammoth Lakes Courthouses. Recently, the court has received additional funding which has allowed for the court to return to normal levels of services at both locations. Starting in October of 2017, the court returned to normal hours of service at the Mammoth Lakes Courthouse, began to answer public phone calls daily from 9:00 AM to 12:00 PM.
